

**NOTICE OF FINDING OF NO SIGNIFICANT IMPACT AND
NOTICE OF INTENT TO REQUEST RELEASE OF FUNDS**

These notices shall satisfy two separate but related procedural requirements for activities to be undertaken by the Sarasota County Resilient SRQ.

REQUEST FOR RELEASE OF FUNDS

On or about January 18, 2025 the Sarasota County Resilient SRQ will submit a request to the HUD Community Development Block Grant-Disaster Recovery Program for the release of CDBG-DR funds under the 1988 Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C. §§ 5121-5206 (Stafford Act), as amended to undertake a project known as Water Control Structure 130 Reconstruction for the purpose of removing the current approximately 150-foot-wide, two-gate structure and replace it with one similar in-kind that is equipped to handle future flood events. The new structure would be installed approximately 40 feet south of the existing WCS, would be approximately 150 feet in width, and approximately 30 feet in length, completely spanning the waterway and occupying 0.1033 acres. The project would occur on City owned land. The entire project site (Proposed Action's limits of disturbance) including any staging areas and access roads, would consist of approximately 1.25 acres. The estimated funding of the proposed project is \$4,417,000 of which \$2,042,000 would be from HUD. The project is located in the Bass Point Waterway Canal at 27.034500, -82.150389.

FINDING OF NO SIGNIFICANT IMPACT

The Sarasota County Resilient SRQ has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. Additional project information is contained in the Environmental Review Record (ERR) on file at Sarasota County Resilient SRQ at 301 N. Cattlemen Rd., Suite 200, Sarasota, FL and may be examined or copied weekdays 9 A.M to 5 P.M.

PUBLIC COMMENTS

Any individual, group, or agency may submit written comments on the ERR to the Sarasota County Resilient SRQ at the above address. All comments received by January 18, 2025, will be considered by the Sarasota County Resilient SRQ prior to authorizing submission of a request for release of funds.

ENVIRONMENTAL CERTIFICATION

The Sarasota County Resilient SRQ certifies to HUD that Steve Hyatt in his capacity as Division Manager, Sarasota Office of Financial Management consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the Sarasota County Resilient SRQ to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

HUD will accept objections to its release of funds and the Sarasota County Resilient SRQ's certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the Sarasota County SRQ; (b) the Sarasota County SRQ has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to the HUD Jacksonville Field Office at 400 W. Bay St. Suite 1015, Jacksonville, FL 32202. Potential objectors should contact this office to verify the actual last day of the objection period.
